## 2023 PARENT AGREEMENT & STUDENT-ATHLETE AGREEMENT

I recognize that First Serve Bridgeport (FSB) is designed to provide a path to success through education and tennis. To accomplish this, FSB requires that each parent and student-athlete joining the program agree to the following:

- I will behave properly and use best efforts to improve on the tennis court, the areas around the tennis courts, including practices, matches, and trips.
- I will arrive on time to practices, matches and trips and will notify FSB staff if I'm unable to attend.
- I will arrive prepared with proper equipment, tennis clothing, and tennis sneakers.
- I will display a positive attitude and good sportsmanship to coaches, fellow players and opponents.
- I will never use vulgar or abusive language.
- I will never make physical contact with another player, staff member or volunteer or deliberately hit them with a ball or racquet.

#### **ACCOUNTABILITY SYSTEM**

FSB does not tolerate poor behavior, disrespect, or unsportsmanlike conduct. The student-athlete will be removed from the situation and the penalty system will be as follows:

<u>1st Offense</u> 1. Written warning.

2. Student-athlete develops plan for improvement with FSB staff.

**2<sup>nd</sup> Offense** 1. Written warning.

2. Student-athlete submits written apology and revises improvement

plan with FSB staff.

3. Parent Contact.

**3<sup>rd</sup> Offense** 1. Meeting with student-athlete and

parents to discuss improvement plan,

timeline and accountability.

4<sup>th</sup> Offense 1. Suspension from program.

2. Meeting with parents to discuss

details.

#### WAIVER & RELEASE OF LIABILITY FORM 2023

- 2) Because of the dangers of participation in tennis and fitness training, I recognize the importance of the coach's instructions regarding playing techniques, training, rules of the sport, or to the team rules, and to obey those instructions.
- 3) I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
- 4) I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and.
- 5) In consideration of First Serve Bridgeport permitting me to practice, play or tryout for the FSB program, and to engage in all activities related to the team, including practicing, playing and travel, I hereby voluntarily assume all risks associate with participation and agree to exonerate and save harmless FSB, their agents, servants, employees, the FSB athletic staff, the physicians, athletic trainers, and other practitioners of the program teaching me, from any and all liability, claims, causes of action or demands of any kind and nature whatsoever which may arise by or in connection with my participation in any activities related to FSB.
